

CONDITIONS OF ENTRY

Eligibility Criteria

- Open to all artists in the Greater Toronto Area.
- Applicants must be 18 years of age or older.
- Artwork must be original and completed within two years of the entry deadline.
- All media is eligible. The theme is open.
- Entries will be juried as digital images and must be **burned to a CD** in a jpeg or pdf format with a minimum of 72 ppi (pixels per inch) and a maximum of 150 ppi. No photographs please.
- The following information must be included on the Entry Form for each image: artist's name, title, date, media, and dimensions of work as well as any special installation instructions.
- A maximum of two works may be submitted by each artist for consideration by the jury.
- A short artistic statement (maximum 100 words) and artist biography (maximum two pages) should accompany each work.
- Two-dimensional works must be framed/mounted and have wire or hardware affixed to the back to facilitate hanging from chains. No rolled paintings or drawings can be accepted.

Submission Deadline/Fees

- Entries including all support material must be received in full no later than **Friday, April 9, 2010**.
- Please submit a non-refundable \$20.00 cheque made payable to the City of Vaughan to cover handling fees.
- Artists meeting the submission deadline will be notified of acceptance by April 30th, 2010.

Selected Works/Awards

- All decisions made by the jury panel are final.
- The jurors reserve the right to disqualify any original work misrepresented by the digital files.
- No entry may be withdrawn from the exhibition until after closing on June 27, 2010.
- The City of Vaughan has permission to photograph and/or share images of accepted work for publicity, educational and reference purposes.

- Entries will be judged for the following cash awards: Best in Show, Reserve Best in Show and the People's Choice. In addition, an honorarium may be awarded to an artist for work if it is selected for City ownership in the *Art Integration Program*.

Submission Checklist

Entries must be accompanied by the following support material:

- Completed Entry Form (attached)
- CD containing digital files labeled with artist's name/art titles
- Entry Fee (cheque made payable to City of Vaughan)
- Artist Statement as Word document
- Artist Biography as Word document

Art Transportation

- Shipping arrangements and associated transportation costs are the responsibility of the artist.
- Works must be delivered to the City Playhouse Theatre on **Tuesday, May 25 between 10 am and 4 pm**.
- After the exhibition closes, works must be picked up on **Monday, June 28 between 10 am and 4 pm**.

Insurance

- The City of Vaughan will insure works while on the premises until the specified pick-up dates, but will not insure works while in transit.
- Artists are required to provide insurance values for their works on the Entry Form.
